8) In view of the above, <u>FIRE NO OBJECTION CERTIFICATE</u> for the above said building is issued <u>subject to the following conditions</u>.

- 1. The NOC issued is confined to the fire safety Measures installed in the building and does not confer any legal right for claiming of Ownership of property or conversion of land use / Occupancy or Building Regularization. The Owner / Occupier shall comply the Building Rules /Govt Orders as applicable.
- Fixed and first-aid Fire Fighting equipment, alarm etc shall be tested and maintained regularly as per applicable standards and Fire-Drills conducted quarterly for first two years and half yearly after two years.
- 3. No temporary structure such as tents or with thatched construction should be allowed for educational institutions.
- 4. The Management shall restrict the occupant load to 120 per floor. If the occupant load increases to more than 140 per floor, an additional staircase of minimum 01.25 mtrs width shall be provided and report compliance.
- The management is advised to provide 20,000 Ltrs of Overhead tank with RCC Construction And report compliance.
- Emergency power generator etc, and associated equipment should be tested periodically, verified as per NBC, and IS-1646.
- Every room with a capacity of 45 students shall be maintained obstruction free minimum two doorways.
- 8. Every vertical opening between at the floors shall be suitably enclose or protected, with ventilation System by ducts and Balconies.
- The Builder / Occupier should facilitate periodical inspection by jurisdiction station Fire Officer and District Fire Officer, Fire Prevention Wing, GHMC, Hyderabad.
- 10. Evacuation plan at showing exit routes and recommended action plan be displayed at conspicuous locations and shall be exhibited all times, all escape /exit routes shall not be blocked or encroached.
- 11. Fresh NOC would be required for any change in occupancy or additions/alterations in the building structure as per NBC of India and building bye/laws.
- 12. The Management has to maintain Fire Safety Measures at all times in good working Conditions as seen during the inspection.
- 13. Any loss of life or property due to Non functioning of Fire Safety Measures and other installation shall be the responsibility of management/owner.
- All the Occupants must know the correct method of operation of the Fire Fighting System Installed.

All Occupants/ security personnel shall be trained to operate the Fire Safety Equipment during the Emergency.
